## Tournament Rules

- Five (5) fish limit per boat; scoring is by boat weight.
- 14-inch size minimum measured on a golden rule (Largemouth & Kentucky); 18-inch minimum for Smallmouth.
- All fish must be weighed from water. No fish will be weighed if you trailer.
- Any fish that appears to have been altered in any way will be weighed only at the discretion of the Tournament Director.
- All fish will be released at time of weigh in.
- Only safe boats will be allowed.
- Life jackets must be worn when big engine is running.
- Any intoxicated participant will be disqualified.
- Tournament hours: 7:00p.m. – 7:00a.m.
- In the event of a 1<sup>st</sup> place tie, the money will be split evenly.
- No fishing or landing fish except from the boat.
- There will be live well checks.
- Artificial bait only, no trolling.
- Participants may fish with a partner or alone; scoring is by boat weight. Entry fee is the same.
- Please be considerate of others when launching and all other times while fishing our tournament.

### SCORING:

- Each team may weigh in five (5) fish, with a minimum of 14 inches in length, unless state or lake limits are greater, measured on a golden rule with mouth closed and tail compressed.
- One dead fish will be allowed. If a second dead fish is weighed in the fish will not be weighed and a penalty of loss of the biggest fish and one (1) pound will be deducted from total weight.
- Only largemouth, spotted, red-eye or smallmouth bass will be scored. Any team weighing in a fish shorter than the legal tournament length will be assessed a one (1) pound penalty plus the loss of the short fish.
- Each team is required to leave from and return to a specified check point.
- Any team returning to the check point late will be penalized at the rate of one-half pound per minute up to 15 minutes.

## :Liability Release:

In signing this application, I hereby release the host, owners, employees, sponsors, and tournament officials from any damages, claims, demands, costs, or expenses relating to injury of any persons or damage to any property which I sustain or which I may cause by reason of participating in or in connection with this Gary Lindsey Memorial Firecracker Benefit Tournament.

I further agree that I will never sue any of the above for damages on account of any injury I suffer or cause, whether known or unknown now or which may develop in the future, in connection with the Gary Lindsey Memorial Firecracker Benefit Tournament.
